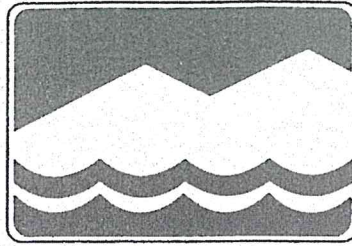

CALL TO ORDER: Chairman G. Petriccione called the meeting to order at 7:40pm.

APPROVAL OF MINUTES: A motion was made by W. Pelletreau, seconded by J. Ginnetty to approve the Lake Lillinonah Authority June 2, 2015 meeting minutes as written. Motion passed unanimously.

INTRODUCTION OF GUESTS – Jeffrey Kilberg, Nicholas Tobin Insurance Agency and Georg Walker, Friends of the Lake

Jeffrey Kilberg from Nicholas Tobin Insurance Agency, gave an overview of the Lake Lillinonah Authority 2015 Insurance Policies.

CORRESPONDENCE: Chairman G. Petriccione reported receiving correspondence from residents complaining of weeds in the lake. Residents were instructed to not cut the weeds back or rake them themselves, but to have it professionally cleaned, i.e. suction harvesting. He also reported receiving a grant from First Light & Power and yearly contribution payment from First Light & Power. Chairman G. Petriccione stated that Mr. Rudy Zeitler, representing Southbury, has resigned from the Lake Lillinonah Authority.

OFFICER REPORTS: Second Vice Chairman B. Piepho stated that he has received water quality sample reports for the month of June. Sampling was from the Still River and the Housatonic River.

NEW BUSINESS: New Business was discussed under the report from Jeffrey Kilberg of the Nicholas Tobin Insurance Agency.

OLD BUSINESS: Chairman G. Petriccione reported the following vacancies:
