**REGULAR MEETING MINUTES  
TUESDAY, AUGUST 1, 2017

**CALL TO ORDER:** Chairman G. Petriccione called the meeting to order at 7:33pm.

**APPROVAL OF MINUTES:** A motion was made by B. Piepho, seconded by J. Ginnetty, to approve the LLA July 11, 2017 meeting minutes as written. Motion passes unanimously.

### **OFFICER REPORTS**

**CHAIRMAN'S REPORT:** Chairman G. Petriccione stated that the dock project will be on the Wetland's Commission's Meeting agenda on August 14, 2017. He also stated that there will be a Public Hearing on September 14, 2017 regarding the shed and gas tank. Several items were requested, i.e. check to see if tank was leaking in any manner between the tank and containment tank, checking verification on the tank every year, drawings on the actual bulk head or head wall, how the docks are being attached to shore, etc. All requests have been complied with. The Fire Marshall will contact the Chairman if there are any issues. Chairman G. Petriccione stated he received drawings and prices to complete the boat and forwarded to Metal Shark. Chairman G. Petriccione spoke with the VP at Metal Shark and price quote has been approved. Chairman G. Petriccione will double check measurements. Chairman G. Petriccione stated that he will need to find a place to dock the Stratus.

**FIRST VICE CHAIRMAN'S REPORT:** In First Vice Chairman S. Young absence, Chairman G. Petriccione stated that NE Aquatic was successful in removing water chestnuts from the Lake. It was suggested that we contact other agencies i.e. Still River Alliance, Angry Beavers, HVA, etc., to understand the focus and address this issue as well. Second Vice Chairman W. Pelletreau volunteered to get the word out.

**SECOND VICE CHAIRMAN'S REPORT:** Second Vice Chairman W. Pelletreau stated that he read an article on Lake Quassapaug regarding their three-year project to remove milfoil using vacuum suction harvesting and diver. Second Vice Chairman W. Pelletreau also stated he will
