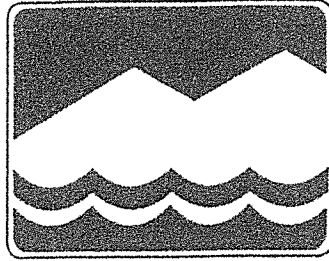

OFFICER REPORTS

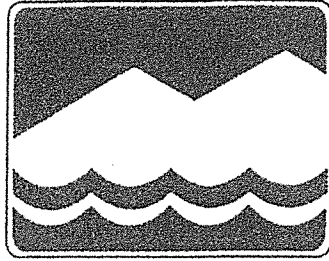
