***Hydrilla** – G. Bolland, FOTL, provided an update on Hydrilla. He stated that Firstlight Power has increased the budget for monitoring. He also stated that there has been an increase from 2024-2025 of colonized Hydrilla within Lake Lillinonah. Post treatment surveys were performed in those areas and proved very good control over the areas that Pond and Lake treated. CT Deep committed to \$50,000 of federal funding to what is seen on that map to be treated thru Pond and Lakes proposal. Treatment was not as thorough as last year. There were two treatments of a granular style herbicide, which is a slower release. This treatment will be followed by a foliage contact treatment of late season. FOTL is working with FirstLight Power to have their commitment to continue increased monitoring for Lake Lillinonah. FOTL for the 2026 season will apply for the AIS Grant to cover newly founded areas of colonization, if granted. G. Bolland, asked Chairman S. Young for a letter of support from the Lake Lillinonah to include with the AIS Grant.
