CALL TO ORDER: Chairman S. Young called the meeting to order at 7:30pm.

***Hydrilla** – G. Bollard, FOTL stated that Friends of the Lake along with LLA support applied for an AIS Grant, in the amount of \$45,000 for additional funding for the treatment of hydrilla. Application was submitted on time. He also stated that \$50,000 of federal money has been awarded to Lake and Pond. G. Bollard reported that James, Connecticut Federation of Lakes is working on permitting changes with CT DEEP. G. Bollard will provide LLA an update.

***Boat Acquisition** – Chairman S. Young spoke with Marine Patrol Chief John Puglisi to clarify where the funding or application for the new boat would come from. Marine Patrol Chief J. Puglisi felt the money could come from the Towns, but is aware that there is not enough money in the LLA fund to pay in full for their boat request. He reported that CLA asked the Towns for a separate assessment in the amount of \$150,000 for their new boat.
